Statement of Purpose

Since the fire at the Good Samaritan Village in St. Francis on October 19, 2010, our community has become acutely aware of the importance of this segment of our population and those that care for them. We lost approximately 50 individuals from our community to other facilities. Close to 60 community members have lost their jobs in Cheyenne County, representing 13% of the total wage earnings in the county. Our hospital and clinic will provide \$300,000 fewer services per year without a nursing home.

The immediate purpose of the *Senior Living for Cheyenne County Fund* is to raise money to help research and determine the best solution for rebuilding a facility, or facilities, to benefit the elderly and individuals with special needs, in Cheyenne County.

The long-term purpose is to raise funds to construct such a facility, or facilities.

Funding Campaign

The avenues for funding this project are readily available through Bird City Century II Development Foundation and St. Francis Community Foundation, both are 501(c)(3) public charities, which allows the highest available tax deductions by the IRS on contributions.

Fund Establishment

Bird City Century II Development Foundation and St. Francis Community Foundation have the common goal of raising funds to benefit *Senior Living* in Cheyenne County.

A task force has been appointed by the Cheyenne County Commissioners to research and determine the best solution for senior living and long term care needs in Cheyenne County. This task force will also serve as the Advisory Board for the *Senior Living for Cheyenne County Field of Interest Funds*.
