Bird City Strategic Plan 2014-2019

Town Hall meetings to update the current Bird City Strategic Plan were held November 14 & 19, 2013. The meeting dates/time were advertised, to encourage public attendance, thru the Bird City Times, www.birdcity.com, Get Bird City Facebook page, flyers and table tents.

The meetings were facilitated by Cathy Domsch, Bird City Century II Development Foundation Executive Director.

This is the third set of town hall meetings to create/update a strategic plan for the Bird City community in nine (9) years. The group in attendance reviewed goals that were accomplished the past three (3) years. This strategic planning process will include the Social and Physical Environments. The strategic plan for the Economic Environment will be handled by a different process.

November 14, 2013: Attendees, as a full group, brainstormed projects and programs they would like to see accomplished in their community in the next 3-5 years for the Social and Physical Environments.

Social Environment

Cheylin Fundraiser (23)

- This was a previous strategic plan goal of which \$23,000 was raised of the \$50,000 goal.

Bird City Clinic Expansion (21)

- The community would like to see the hours, services and space of the clinic expanded.

Gym Floor in McDonald (16)

- In dire need to be resurfaced; was not done correctly last time and very slick.

Dentist/Optometrist (9)

- A goal of the previous strategic plan was to increase health care services, a chiropractor was acquired, and the group still feels the community could support a dentist and optometrist.

Portable Outdoor Theater System (8)

- This has been discussed among a small group of people in the past, and Big Ed's has donated \$1,000 to the Foundation for this project.

Warning System (7)

- Members of the community feel that a better warning system should be in place to better protect our residents in case of storm, tragedy or disaster.

Sound System – McDonald Gymnasium (5)

- The current sound system is very poor quality.

Football Scoreboard (3)

- The current scoreboard does not work properly.

Bike Path (2)

- Community members would like to see a bike path around the perimeter of the town.

Physical Environment

Old Theater/Brownfields (23)

- Community members would like to see the old theater building torn down, possibly using the Brownfields program to assist with any environmental clean-up.

Storm Shelters (14)

- Community members would like to see storm shelters strategically placed throughout Bird City for the protection of its residents in event of a tornado or other disaster.

Cabins/Lodging (14)

- There is a need for lodging options for hunters, bicyclists, family or community events.

'Round-About' (14)

- A 'round-about' type landscaping option was discussed and set as a goal of the prior Bird City Strategic Plan but never acted upon. The group would like to look into this further.

Housing/HAT/CDBG Rehab/Rentals (14)

- Housing is a critical issue for future development, including rentals. A Housing Assessment Tool (HAT) must be completed prior to applying for a Housing Community Development Block Grant (CDBG) thru the Kansas Department of Commerce (KDOC).

Water Tower Project (13)

 City Council has been approached in the past about considering painting or wrapping the water tower to resemble a birdhouse. This project could possibly be incorporated in the CDBG/KDHE water project that will be taking place in Bird City to improve our water system.

Recycling/building & compactor (5)

- As discussed in the last strategic plan, enhanced recycling facilities in Bird City would be beneficial, including a building and cardboard compactor.

Deb Smith is concerned about a shelter for Lebow Manor residents, and has been researching options as well. As noted above in the theater building updates, the old theater building location cannot be an option for the storm shelter at this time.

June 2014: Velda Wright reported that Devon Conley is working with Fire Chief Loren White on establishing existing locations, and once formally established as such they will be able to educate the community. Dan Sowers may be interested in working with the group to have something built on his vacant lot downtown.

June 2014: Velda Wright reported that the next step is to attend City Council to inquire about the project, if it is something that Council will approve. Water will be needed if do something with plants. Velda reported that this intersection is the location of where the first well was dug in Bird City.

October 2014: Velda Wright presented a map of the 4-way intersection with dimensions showing the area available for the Round-About. She presented the area to include a 'Truck Apron', a concrete circle which would allow trucks to have a little more space to get around. The area is estimated to be up to 10' in diameter. Discussion was held on ideas to put inside the Round-About. Lack of water being fed to the area is a concern for plants. Velda would like it to include "Bird City", putting our name into the downtown community. Rod Klepper suggested a flag pole with lights. Darci thought the possibility of engraving "Bird City" into a brick décor around the base of the pole. Cindy said she has photos of one from another community that incorporated large rocks into their Round-About. NEXT STEP — Velda will attend a city council meeting to get their approval to move forward with this project.
